

**“SPTV AT HOME SWEEPSTAKES”  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES** (defined below). A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS OPEN ONLY TO PERSONS WHO ARE, AT THE TIME OF ENTRY, LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES OR THE DISTRICT OF COLUMBIA, AND AT LEAST EIGHTEEN (18) YEARS OF AGE OR OLDER. A MINOR (DEFINED BELOW) SHOULD HAVE THEIR PARENT OR LEGAL GUARDIAN’S PERMISSION PRIOR TO ENTERING THE SWEEPSTAKES.

**SWEEPSTAKES ENTRY PERIOD & SPONSOR:** The “SPTV AT HOME SWEEPSTAKES” (“**Sweepstakes**”) promoting the Sponsor’s (defined below) television shows (the “**Shows**”) starts at 9:00:00 am Pacific Daylight Time (“**PDT**”) on 5/15/20 (May 15th 2020) and ends at 8:59:59 am PDT on 6/19/20 (June 19<sup>th</sup> 2020) (“**Sweepstakes Period**”). Sweepstakes consists of five (5) weekly drawings (each a “**Weekly Drawing**” and collectively “**Weekly Drawings**”) with each Weekly Drawing having its own specific entry period (as detailed below) and one (1) Grand Prize drawing (“**Grand Prize Drawing**”) from among all eligible Entries (defined below). Weekly Drawings and Grand Prize Drawing may be referred to collectively as “**Drawings**”. The sponsor of the Sweepstakes is Sony Pictures Television, Inc., 10202 W. Washington Blvd., Culver City, CA 90232 (the “**Sponsor**”). The administrator of the Sweepstakes is West Coast Marketing, a division of The Susquehanna Hat Company (“**West Coast Marketing**” or “**Administrator**”). The Sweepstakes is subject to these Sweepstakes Official Rules (the “**Official Rules**”), and by entering, entrant agrees to be bound by them.

**ELIGIBILITY:** Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia (the “**Eligibility Area**”), who as of the date of their entry into the Sweepstakes are eighteen (18) years of age or older. Employees of Sponsor, Showtime Network, CBS Interactive Inc., West Coast Marketing, Sun Basket, Inc. and each of their respective affiliates, subsidiaries, parent companies and agencies (collectively, the “**Sweepstakes Entities**”), as well as members of such employees’ immediate families (spouses, children, siblings, parents) or households (whether or not related), are not eligible to participate in the Sweepstakes. Sweepstakes is void in Puerto Rico, all U.S. territories and possessions, overseas military installations and where prohibited or restricted by law. A prize won by an individual at least eighteen (18) years of age but considered to be a minor (“**Minor**”) in his/her legal jurisdiction of residency will be awarded in the name of Minor’s parent or legal guardian.

**HOW TO ENTER: THERE IS A LIMIT OF ONE (1) ENTRY PER PERSON PER WEEKLY ENTRY PERIOD DURING THE SWEEPSTAKES.**

To enter the Sweepstakes, eligible individuals may visit the website at [stayhomewith.sonypictures.com](http://stayhomewith.sonypictures.com) (“**Sweepstakes Site**”) during the specific Weekly Drawing Entry Period and follow the directions for entry registration in the Sweepstakes by inputting your personal information (first and last name, email address, zip code, daytime telephone number and month, date and year of birth) and clicking “Submit”. By successfully completing the foregoing and subject to the entry limitations detailed herein you will receive an “**Entry**” in the Sweepstakes.

Each individual submitting an Entry may be referred to as an “**Entrant**”.

Any attempt by any participant to enter by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that participant’s Entries and that participant may be disqualified, at the sole discretion of Sponsor. Use of any automated system to participate in Sweepstakes is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, stolen, damaged, misdirected or illegible

Entries or for postage-due mail or for computer hardware or software failures, malfunctions, errors or difficulties of any kind, whether human, electronic, computer, mechanical, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of Entries, the announcement or notification of the prizes or in any Sweepstakes-related materials.

The Sponsor's database clock will be the official timekeeper for this Sweepstakes.

All federal, state, and local rules and regulations apply.

For purposes of this Sweepstakes, an Entry is "received" when the Sponsor's server records the Entry information. Proof of sending (such as an automated computer receipt confirming Entry or "thanks for entering" message) does not constitute proof of actual receipt of an Entry for purposes of this Sweepstakes. Illegible and/or incomplete Entries and Entries submitted by Entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Those who do not follow all of the instructions, provide the required information in their Entry or abide by these Official Rules or other instructions of Sponsor may be disqualified.

It may further use the personal information, including but not exclusively, name and email, to send you information about Sponsor. Sponsor will provide you with an opportunity to opt-out of receiving this information at any time after you first receive such information from Sponsor. Sponsor may also provide the personal information you provide to enter this Sweepstakes to third party fulfillment companies so that such companies may process and deliver prizes to winners.

## **WINNER SELECTION:**

**Weekly Drawing Prize winners:** According to the Weekly Drawing Prize Schedule detailed below, potential Weekly prize winners will be selected for each of the five (5) Weekly Drawings in a random drawing from among eligible Entries received for that Weekly Drawing. The potential prize winners will be notified by telephone and/or email within three (3) days of applicable Drawing.

It is the Entrant's responsibility to timely set account settings to accept email and telephone contacts by Sponsor and to timely check your email account or voice mail for such messages. Sponsor is not responsible for any failure of delivery of notice attempting to use such method.

Each Potential prize winner agrees to sign any further documentation requested by Sponsor and return it within the same time period.

The ARV of the Grand Prize is \$1,698.99.

Weekly Drawing Prizes and Grand Prize may be referred hereafter as a “**Prize**” and in the plural as “**Prizes**”.

The total ARV of all Prizes to be awarded in the Sweepstakes is \$4,998.

All federal, state and local tax liabilities, if any, are the responsibility of the Prize winners. **Prizes are not transferable, assignable, or redeemable for cash.** Prizes will be fulfilled within 6-8 weeks of verification of winners and delivered by mail or other delivery service as determined at the sole discretion of Sponsor. There is a limit of one (1) Weekly Drawing Prize per person and/or household.

**Prizes may NOT be sold, bartered or exchanged by Prize winners. If any of the Sweepstakes Entities discover that a Prize has been “put up” for sale, bartered or exchanged by Prize winner or any other individual or entity, Sponsor reserves the right to immediately reclaim the Prize and no substitute Prize will be awarded.** No Prize substitution will be allowed. Specific elements of the Prizes are at the sole discretion of the Sponsor. If necessary, due to unavailability of a Prize for any reason, a Prize of comparable value may be awarded at the sole discretion of the Sponsor. Prizes are provided "as is" and without any warranty of any kind. By accepting a Prize, the Prize winner acknowledges and agrees to compliance with these Official Rules. All federal, state and local tax liabilities are the responsibility of the Prize winners.

**RELEASES:** The Sweepstakes Entities and any and all Internet server(s) and access provider(s) and email services, and each of their respective affiliates, subsidiaries, parent corporations, retailers and advertising and promotional agencies, and all of their officers, directors, trustees, managers, members, partners, shareholders, employees and agents, (collectively, "**Releasees**"), are not responsible for: any incorrect or inaccurate Entry information; human errors; technical malfunctions; failures, omissions, interruptions, deletions or defects of any telephone network, computer online systems, computer equipment, servers, providers or software, including without limitation, any injury or damage to participant's or any other person's computer or mobile device relating to or resulting from participation or attempted participation in the Sweepstakes; inability to access the Sweepstakes Site or any pages thereof or upload photograph(s); theft, tampering, destruction or unauthorized access to, or alteration of, Entries; data that is processed late or incorrectly or is incomplete or lost due to telephone, computer or electronic malfunction or traffic congestion on telephone lines or the Internet or any website or for any other reason whatsoever; typographical, printing or other errors; late, lost, stolen, mutilated, misdirected or postage-due mail, or any combination thereof. Proof of submitting Entry information is not considered proof of delivery or receipt of data. Illegible or incomplete Entries, Entries in excess of the stated number above and mechanically reproduced Entries will be disqualified. All Entries become the property of the Sponsor and will not be acknowledged or returned. False, fraudulent or deceptive Entries or acts shall render Entrants ineligible. By entering the Sweepstakes, Entrants affirm that they have read and accepted these Official Rules.

**DISPUTES:** Except where prohibited, Entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any Prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate Federal or state courts located in Los Angeles County, California; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred (if any) not to exceed fifty dollars (\$50), including costs associated with entering the Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages and any and all rights to have damages multiplied or otherwise increased, other than for actual out-of-pocket expenses. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of California without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California.

By entering into the Sweepstakes, you agree that any controversy or claim arising out of or relating to this Sweepstakes (including without limitation its pricing) or relating to these Official Rules, their enforcement, arbitrability or interpretation, shall be submitted to JAMS ("**JAMS**") for final and binding arbitration under its comprehensive arbitration rules and procedures if the matter in dispute is over \$250,000 USD or under its streamlined arbitration rules and procedures if the matter in dispute is \$250,000 USD or less, to be held in Los Angeles, California, before a single arbitrator. The arbitrator shall be selected by mutual agreement of the parties or, if the parties cannot agree, then by selecting an arbitrator from a list of arbitrators supplied by JAMS. If the parties still cannot agree on an arbitrator, the arbitrator shall be appointed by JAMS. The arbitration shall be a confidential proceeding, closed to the general public. The arbitrator shall issue a written opinion stating the essential findings and conclusions upon which the arbitrator's award is based. The parties will share equally in payment of the arbitrator's fees and arbitration expenses and any other costs unique to the arbitration hearing (recognizing that each side bears its own deposition, witness, expert and attorneys' fees and other expenses to the same extent as if the matter were being heard in court). Notwithstanding the foregoing, the arbitrator may require that such fees be borne in such other manner as the arbitrator determines is required in order for this arbitration clause to be enforceable under applicable law.

**CHOICE OF LAW/LIMITATION OF LIABILITY:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants and Releasees in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of California, USA.

By receipt of a Prize, any and all winners agree to release and hold harmless Releasees from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of such Prize.

**FORCE MAJEURE:** Releasees shall not be liable to a Prize winner or any other person for failure to supply a Prize or any part thereof, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist acts, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, network or computer problems, internet problems, hacking, computer viruses, unauthorized computer access, tampering, or any other cause beyond Sponsor's sole control.

**GENERAL:** If for any reason this Sweepstakes is not capable of running as planned, or if this Sweepstakes or any web site associated therewith (or any portion(s) thereof) becomes corrupted or does not allow the proper playing of the Sweepstakes and processing of Entries in accordance with these Official Rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by Entrants, fraud, technical failures, or any other causes, in the Sponsor's sole opinion, corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, the Sponsor reserves the right, at its sole discretion, to disqualify any individual implicated in such action and/or to cancel, terminate, modify, or suspend this Sweepstakes or any portion thereof. In the event this Sweepstakes is cancelled, the Sponsor will conduct random drawing(s) to award the applicable Prizes from among all eligible, non-suspect Entries received prior to the time of the action or event warranting such cancellation. If such cancellation, termination, modification, or suspension occurs, notification will be posted at Sweepstakes Site. The Releasees are not responsible for the actions of Entrants in connection with the Sweepstakes, including Entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. Persons found tampering with or abusing any aspect of this Sweepstakes, or whom Sponsor believes to be causing malfunction, error, disruption or damage may be disqualified. Additionally, any attempt to cheat the Sweepstakes, as determined at the sole and absolute discretion of Sponsor, may result in immediate disqualification of the Entrant, as well as other possible consequences, including disqualification from any and all existing and future sweepstakes, contest or promotion. ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DAMAGE ANY WEB SITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND/OR CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

If a dispute arises about who submitted an Entry, the Entry will be deemed submitted by the "**authorized account holder**" of the email address used. The authorized account holder of the email address is deemed the natural person who is assigned to an email address by an Internet access provider, service provider, or other online organization that is responsible for assigning email addresses for the domain associated with the submitted email address. A potential Prize winner may be requested to provide the Sponsor with proof that he/she is the authorized account holder of the email address associated with the winning Entry and that all eligibility requirements are met.

In the event a dispute regarding the identity of the individual who actually submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible. The Releasees are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in Entrant's email account to receive email messages or voice mail system to receive voice mail messages. Also, the Releasees are not responsible, and may disqualify an Entrant, if his or her email address or telephone number does not work or if it is changed without Entrant giving prior written notice to Sponsor.

**NOTE:** Entry must be made by the Entrant only as detailed above. automated means are void and may be disqualified. The use of any device or software to automate the Entry process is prohibited. Entries or other Sweepstakes materials that are incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late, misdirected, postage due, deceptive, in greater quantity than the limit stated above or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion.

**MISCELLANEOUS:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on the Sweepstakes Site and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
